PRIVACY POLICY

PURPOSE

The purpose of this policy is to:

- create clarity;
- ensure that privacy centric behaviours are observed; and
- · prevent unwanted behaviours that lead to privacy risk

SUMMARY

At AMI we understand that protecting the personal information of our policyholders is a critically important pillar of the trust relationship. We will do everything that we can to ensure that personal information is processed in ways that align to policyholder instructions and that the information is secured during processing and when the data is at rest. We only partner with entities that take privacy as seriously as we do.

KEY PRINCIPLES

Ami has appointed the AMI CEO as Information Protection Officer (IPO). The IPO is responsible to review the nature and extent of privacy risk, adequacy and effectiveness of controls and implementation of management actions for instances of inappropriate use of personal information.

Privacy principles are embedded into key controls. These include:

- Periodic risk assessments to proactively identify and understand privacy risks
- ☑ Privacy notice that details the purposes for which Personal Information is collected, used, retained and disclosed
- Consent for use where the collection, use and disclosure are not linked to the other processing grounds such as legitimate purpose
- Retention and Disposal processes to ensure we only retain necessary Personal Information to fulfil the stated purposes or comply with legislation and to destroy or depersonalise personal information when we do not need to retain it.
- Access processes so that Personal Information can be reviewed and updated
- ☑ Disclosure processes to ensure that Personal Information is only disclosed to third parties where this has been consented to or is necessary to complete the legitimate purpose
- Processes to secure Personal Information against unauthorised access and cross border transfers
- Ongoing training and awareness
